Tribal Services & Benefits vs. Tribal Distributions

Most Services and Benefits you receive from the Tribe are NOT considered taxable income, but are recognized as our Tribal Government providing for the general welfare of our people, including:

- Elder's Annual Assistance
- Back-to-School Annual Assistance
- Housing Assistance
- Education Scholarship
- Medical benefits and Insurance Copays

However, many Distributions made to members by Tribal Governments are considered taxable income, including:

- Gaming proceeds under IGRA
- Per capita payments
- Distributions of net income from non-treaty derived activities or non-trust lands
