American Rescue Plan Act (ARPA) Annual Performance Report (APR) for 2022

WHEREAS the Samish Indian Nation was federally re-acknowledged by the Assistant Secretary of

the Department of the Interior of the United States of America on April 6, 1996;

WHEREAS the Samish Tribal Council is empowered to act on behalf of the Samish Indian Nation

> pursuant to Article VI, Section 2, of the Samish Tribal Constitution, approved November 14, 2003, by Resolution of the Samish Tribal Council and adopted and ratified by Vote of the Samish General Council on March 2, 2004, and recognized by the Assistant Secretary

for Indian Affairs, David W. Anderson on April 20, 2004;

WHEREAS the health, safety, welfare and education of the citizens and family members of the

Samish Indian Nation is the responsibility of the Tribal Council of the Samish Indian

Nation;

as a recipient of the Indian Housing Block Grant (IHBG) funds under the American WHEREAS

> Rescue Plan Act (ARPA) the Samish Indian Nation must review the progress made to implement the programs included in the abbreviated Indian Housing Plan (IHP) and submit an abbreviated APR to HUD within 90 days of the end of the program year;

WHEREAS to fulfill this reporting requirement Samish Indian Nations Housing Department must

submit to the Northwest Office of Native American Programs (NwONAP) the APR for

the IHP ARPA for the program year that ended December 31st, 2022;

THEREFORE BE IT RESOLVED by the Samish Tribal Council:

1. The submittal of the IHP ARPA Annual Performance Report for 2022 is approved.
